Executive Director's Report Melanie Harthoorn

Have you ever planted seeds and checked on them an hour later, even though you know it takes time for growth? Our excitement can often lead to impatience as we want immediate results. When the Board of BeLoved Care first convened two years ago, we envisioned a supportive care home to be established within three to five years. If you're like us, you wish this care home had already been built, especially given the urgent need we see within our families and churches. It's easy to feel impatient when progress takes longer than expected. While we may not be as far along as we initially hoped, we trust that this first newsletter (of many to come, LORD willing) will illustrate the steps God has guided us through so far. "The heart of man plans his way, but the LORD establishes his steps" (Proverbs 16:9). We are grateful that God's timing is perfect and His wisdom far exceeds our own.



Although we may lament the seemingly slow pace, when I look back on the minutes of our meetings I can clearly see that God has allowed us to accomplish much. Here's a snapshot of our undertakings since inception:

- · Established the organization's vision, mission, and values statements
- · Became incorporated as a not-for-profit
- Created our website, belovedcare.ca
- Toured care home facilities and developed a conceptual plan
- Presented to several local Reformed Church Councils about the mission of BeLoved Care
- Opened bank accounts
- Obtained our charitable status (this was a big step!)
- · Signed up for a CanadaHelps account to receive online donations
- Received our first donations!
- Began engaging with Alberta Health representatives
- Surveyed various land options, made an offer to purchase 3.2 acres from Coaldale Christian School

Looking at the Present

The Board of BeLoved Care realized the value of establishing a care home adjacent to a Christian School because of the many possibilities for mutual benefit, and we are excited to announce that the membership of the Coaldale Christian School voted in favor of selling a portion of the land parcel situated east of the school. Although it is a conditional offer (based on re-zoning, subdivision, and permit approval), both the School Board and the Town of Coaldale do not foresee any difficulties removing these conditions. Additionally, a geotechnical engineering report was undertaken which was very favorable for building on the land. Therefore, BeLoved Care will now begin

working with an architect to finalize the design. Once this has been accomplished, we will determine the cost and begin actively fundraising. "For which of you, desiring to build a tower, does not first sit down and count the cost, whether he has enough to build it?" (Luke 14:28).

We praise God for directing our path, and we thank and praise him for all the help we've received from many of you thus far. From accounting, to virtual assistance, to financial aid, to engineering services, God has blessed many of you with rich talents, and we thank you for your willingness to assist this endeavor.
